CMHA Ontario, Addictions and Mental Health Ontario collaborate On quality improvement initiative to support mental health and addictions sector

Tuesday, Nov. 12, 2013 – Quality improvement is an important feature of the mental health and addictions system. That is why the Canadian Mental Health Association (CMHA), Ontario and Addictions and Mental Health Ontario (AMHO) are working collaboratively and leading an initiative to support community-based mental health and addictions organizations to enhance quality improvement.

CMHA Ontario and AMHO are developing a Quality Improvement Plan (QIP) template which includes a menu of quality improvement indicators for use by Ontario's mental health and addictions sector. This QIP template is being developed in alignment with the attributes of a high-performing health system framework employed by Health Quality Ontario, and is an important step toward preparing for the legislated requirements under the *Excellent Care for All Act* (2010).

This QIP template is the result of the expansion of quality improvement work conducted in recent years by the CMHA Ontario Executive Directors Network and the many initiatives taken by mental health and addiction services to demonstrate their quality.

"One of the strengths of the mental health and addictions sector is our ability to collaborate, create and share tools that increase our collective capacity," said Camille Quenneville, CEO of CMHA Ontario. "Through this work, we are taking the necessary and proactive steps to ensure mental health and addictions organizations can adapt as seamlessly as possible to the provincial government's quality improvement approach."

"By working in partnership to help community-based organizations across the full spectrum of addiction and mental health services and supports, the sector can adapt to future wide-ranging legislative requirements," said David Kelly, CEO of AMHO. "Helping the sector in this way means mental health and addictions organizations can focus on what they do best, providing support to individuals and their families in communities across Ontario."
