## Overview

### Statement of Need

The Canadian Mental Health Association (CMHA), Ontario Division is seeking proposals from qualified individuals/organizations to carry out a quarterly qualitative and quantitative evaluation of *In the Know between April 2022 and September 2023.* 

This Request for Proposals (RFP) is meant to provide a fair evaluation for all candidates and to provide candidates with the evaluation criteria against which their proposal will be evaluated.

## About CMHA Ontario

The **Canadian Mental Health Association (CMHA), Ontario** is a provincial association, committed to improving services and support for individuals living with mental illnesses and addictions issues, and to the promotion of mental health in Ontario.

## About In the Know

*In the Know (ITK)* is a mental health literacy program developed at the Ontario Veterinary College (University of Guelph) created specifically to educate the agricultural community. With support from the Ontario Federation of Agriculture, several CMHA branches in rural and agricultural communities offer this training.

The four-hour mental health literacy workshop is designed to fit with farmers/producers limited availability owing to rigid daily schedules, distilling critical information and incorporating agricultural community culture. The workshop was developed in collaboration with stakeholder groups, including various agricultural sectors, mental health literacy trainers, government and representatives from social work, psychology, epidemiology, and education.

*ITK* is meant for farmers, producers and persons with whom they have regular contact. This may include, but is not limited to, family members, peers and allies in the agricultural industry such as veterinarians, breeders, seed or feed salespeople, financial institutions, accountants or community members who have direct contact with farm owners/operators.

#### In the Know Trainers

ITK has a network of trainers across Ontario within our branches. ITK trainers are given training and ongoing support to deliver sessions to community groups, agricultural organizations and businesses within their communities.

ITK trainers are mental health professions that work directly in our branches day to day and complete an additional agricultural literacy training program prior to delivering ITK sessions.

# **Proposal Details**

## **Proposal Requirements**

The proposal should not exceed ten pages and should include an appendix (not included in the 10 pages) with resume(s) that outlines relevant qualifications and professional experiences. The proposal should include, but not be limited to, the following:

- A cover letter outlining:
  - Your personal or organizational qualifications for this contract
  - Names of staff to be assigned to this project (copy of resume(s) in an Appendix)
  - Summary of proposed budget & timeline
- A work plan that considers all proposed stages and deliverables, including implementation timelines
- A description of your experience in qualitative and quantitative evaluation
- A description of how the applicant plans to collaborate with CMHA Ontario stakeholders, including but not limited to the CMHA Ontario Staff, In the Know Facilitators, CMHA Branches, and agricultural community partners.
- A description on how equity, diversity, inclusion and accessibility will be fundamental in your work
- Examples of prior work similar to this type of project
- A proposed budget breakdown in Canadian funds for the scope of work for this project as detailed in this request for proposals

If selected, you will also need to provide:

• Two references (including agency or business name of client, contact person, email address, and telephone number)

The proposal must contain the signature of either (1) the individual or (2) an authorized representative of the organization submitting the proposal.

#### **Budget**

The maximum budget for this RFP is \$20,000 CAD.

Please submit the proposal listed above no later then **11:59***PM (EST)* on Monday, March **21**, **2022** This is an open and competitive process, so proposals received after the deadline will not be considered. CMHA Ontario has established the following approximate timeframes for the RFP process:

## Proposal Goals and Scope

Currently, the ITK program has a pre and post survey evaluation process, and the vision is for the consultant to conduct a review of the existing tools and establish an evaluation plan that will effectively provide both quantitative and qualitative feedback on the impact ITK has on session participants. Additionally, an evaluation of the program from a trainer and partner perspective is desired to ensure delivery needs are being met.

The selected consultant will review existing evaluation tool and develop a means of enhancing the process to include qualitative information in the form of surveys, follow up interviews, etc. The consultant will also provide summary reports on program enhancements based on evaluation results from trainers and other stakeholders. The consultant will be required to provide data analysis and summary reports on a quarterly basis.

## Scope of Services

During the baseline the consultant and/or the consultancy firm will:

- Review ITK session materials and current evaluation to gain an understanding of the program.
- Lead the ITK team through the process of designing a comprehensive evaluation framework, building on the existing pre and post survey which currently are highly focused on quantitative evaluation.
- Prepare an inception report outlining the methods to be used in the evaluation based on the project's performance measurement framework (including workplan, sampling approach and size, description of data quality assurance protocols to guide data collection/entry, guidance/training for baseline tool implementation, description of data analysis process and data analysis framework). The current evaluation framework is included in Appendix B.
- Support the integration of the evaluation framework into new and existing evaluation tools.
- Collaborate with the ITK team on establishing KPIs for the evaluation that are in line with our Strategic Goals.
- Implement outreach with ITK stakeholders to evaluate ITK. This includes consulting with ITK staff, ITK trainers, program partners, program participants, and other key stakeholders as deemed appropriate.
- Provide quarterly analysis reports to the Director of Programs, Team Lead of Farming Mental Health and ITK Program Manager.

#### Closure & Handover

- Applicant will need to propose a closure and handover process
- Provide all documents, including cleaned and raw data analysis work, to CMHA Ontario in Microsoft Excel, Word, PowerPoint, and PDF

CMHA Ontario will be responsible for:

- Providing all current ITK curriculum materials
- Convening relevant stakeholders on the consultants' behalf for the curriculum audit and needs assessment
- Supporting the development and making final decisions on new evaluation content
- Provide branding guidelines for producing materials
- Convening relevant stakeholders on the consultants' behalf for evaluation roll out, closure and handover

## Guiding Principles: Equity, Diversity, Inclusion & Accessibility

CMHA Ontario is committed to EDIA across all programs. The consultant will ensure ITK evaluation will reflect the communities we serve, address social inequities within agricultural mental health, and will be inclusive of participants.
